## 6.0) SCOPE OF WORK

- 6.1. Supply, Erection and Commissioning of Passenger cum Goods Lift - 1 No. at Research and Development Laboratory, Products Dairy, Ambattur on F.O.R. destination basis conforming to the technical specifications mentioned in the tender document.
- 6.2. The specifications of the lift as mentioned in the clause No. 28.0 are the requirements of tender, however higher specifications of lift may be considered subject to their cost economics i.e. competitiveness in financial terms for the particular location.
- 6.3. After the supply of lift as mentioned in the clause No. 28.0, the bidder has to execute their Erection & Commissioning at our site (R&D Laboratory, Ambattur, Chennai-98). Successful commissioning at the site is the responsibility of the supplier. During Erection and Commissioning the supplier should keep all the items required at site and arrange to carry out the job with their team, materials, tools, other equipments etc. under their own arrangement and supervision. Necessary site data as required will be provided by the purchaser. Non-availability of any facility at the site of the purchaser shall not be treated as breach of the contract or reason for delay in handing over the lift. No extra cost shall be paid for Erection & Commissioning. The required civil & electrical works for the erection will be provided by the purchaser.
- 6.4. Foundation drawing, if any, should be handed over to the purchaser within two weeks from the receipt of the supply order.
- 6.5. After the Erection & commissioning of lift, training to our officials shall be given for 3 Working Days, wherein, the training about the lift's operations, maintenance, information about Do's & Don'ts as well as trouble shooting & all other areas which are necessary for smooth functioning of lift shall be provided at site, by the bidder. No extra cost shall be paid to the successful bidder for imparting this training.

- 6.6. The bidder shall offer on-site comprehensive warranty of lift for one years from the date of successful commissioning of lift at the designated location. The purchaser is not liable to pay any extra charges on any account during warranty period.
- 6.7. The bidder shall cover the lift under Maintenance Contract for Two years after the expiry of warranty period without asking for any additional financial charges from purchaser.
- 6.8. The bidder shall obtain the license for erection and operation of the lift from the competent authority and all the expenditures to be borne by the bidder. No additional cost will be paid by TCMPF Ltd. to the bidder to obtain Lift license. Bidder shall clearly inform the required documents for lift license purpose in the quotation itself and the TCMPF Ltd. will provide necessary documents to the bidder for obtaining the license from the competent authority as required by the bidder during the process.

- 9.3). The EMD will not carry any interest.
- 9.4). Bidder has to select the payment option as "pay online" to pay the EMD amount. Only after payment of EMD, bidder will be able to encrypt/upload their bids. In order to avoid any issues and last-minute delay in processing of payment online, it is recommended to make payment and submit the bid as early as possible. # 9.6). Online payment mode (EMD):

9.6.2). Any transaction charges levied while using any of the above modes of online payment has to be borne by the bidder.

9.6.3). The bidders will be evaluated only if payment status shows "Success" during bid opening. It is necessary to click on "Freeze bid" link/icon to complete the process of bid submission, otherwise the bid will not get submitted online and same shall not be available for viewing/opening during technical bid opening.

## 9.7). Refund of EMD of unsuccessful bidders:

The EMD paid by the bidder will automatically be deposited in the "Pooling Account" of the State Govt. only and not in TCMPF Ltd.'s account.
