 3. The tenderers are to submit the Original set of the two-part tender (both Part-I - Technical Bid and part II Commercial Bid) duly filled in, attaching necessary documents and they are advised to retain the duplicate set of documents for their reference / records.
 4. The Part-1 pre-qualification cum technical bid consisting of page nos. 1 to 33 and the part-II Commercial bid consisting of page Nos.34 to 35 should be submitted in two different covers duly superscribed as "Tender for the contract for Providing 6 Nos manpower having 1 year Ammonia Refrigeration experienced ITI/Diploma/ Refrigeration Technician qualified operators for Operation & Routine Maintenance of 600MT Butter Deep Freezer Ammonia Refrigeration Plant with H.S. 4. GENERAL TERMS AND CONDITIONS

TWO PART TENDER for the contract for “Providing 6 Nos manpower having 1 year Ammonia Refrigeration experienced ITI/Diploma/Refrigeration Technician qualified operators for Operation & Routine Maintenance of 600MT Butter Deep Freezer Ammonia Refrigeration Plant with H.S. Screw Compressor, Frick Vilter Two stage Compressors with all related equipment’s with each 100MT Frozen Chamber-6 Nos SCADA operation system and maintain the temperature between(Minus) -15°C to -18°C & IRS plant routine maintenance cum shift reliever for TWO years contract period (2025–27) for round the clock operations from the date of awarding Contract at Ambattur Dairy” from the date of execution of agreement by the tenderer.

- 4.1 The tenderer should have successfully completions 600MT BDF plant with Ammonia Two-stage Vilter/Screw Compressors period minimum experience Twelve months as on the date of opening of technical bid of having provided labour on contract basis to any Govt. organization/Co-op. institutions or any reputed private organization within the period minimum 1 year. The Federation reserves the right to inspect any organization where the tenderer provided labourers on contract basis. The copies of work order or any other authentic document to show that the tenderer has such experience should be enclosed as evidence.
- 4.2 The tenderer should furnish an Earnest Money Deposit of Rs.73,000/- (Rupees Seventy three thousand only) by means of Online payment only. No other form of remittance will be allowed.
- 4.3 The tenderer shall have minimum manpower strength of Seven persons.
- 4.4 The tenderer should provide one person each in 3 shifts and three persons for Maintenance/Shift reliever as detailed in the Scope of work given hereunder in separate head.
- 4.5 The tenderer should furnish photos at copy of documentary evidence for having provided man power in a single organization for minimum six month on contract basis to any Govt. organization/Co-op. Institutions or any reputed private organization within the period minimum 1 year as on the date of submitting the tender.
- 4.6 The tenderer should have E.P.F. & E.S.I. registration certificates.
- 4.7 The tenderer should have PAN CARD.
- 4.8 The tenderer should have GST registration certificate.
- 4.9 The PART-I Technical Bid shall be opened on the date, time and venue specified, in the presence of the tenderer or their authorized representatives who opt to be present during the opening.
- 4.10 PART I Technical bid, specifies the pre-qualification based on various factors such man power strength, capacity, suitability etc., and eligibility of the tenderer, that will be evaluated, considered and decided prior to opening of the commercial Bids under part II of the tenderer.

- 4.11 The tenderer(s) who do not satisfy any/all the terms and conditions specifically so mentioned under PART-I Technical bid, are not eligible for commercial bid and the Part II Commercial Bid shall not be opened, treating it as non-responsive.
- 4.12 THE PART-II Commercial bids shall normally be opened within 90 days at the convenient date and time of Tender Inviting Authority from the date of opening of the part-I Technical Bids Part II Commercial bid will be opened in the presence of tenderers or their authorized representative who opt to be present at the time.
- 4.13 The date of opening of commercial bid will be intimated separately to those who qualify in the PART-I Technical bid.
- 4.14 The Tender forms are not transferable or assignable.
- 4.15 No revision of rate will be entertained at any cost during the tender period. The variation in the GST or any other tax by the Government shall be effected on the end price to the benefit of either the tenderer or the Federation as the case may be.
- 4.16 No revision of daily wages by the District Collector etc., during the period of the contract, the successful tenderer should alone bear such escalation and the successful tenderer shall not claim any additional amount for such escalation.
- 4.17 The signatory of the tenderer should indicate his/her/their status in which he/she/they have signed and should submit necessary legally admissible documentary proof in respect of such authority assigned to him/her/them by the firm.
- 4.18 If the tender opening day is a declared holiday, the tenders shall be received and opened immediately on the next working day at the same time and place.
- 4.19 No tenderer shall be allowed to withdraw the tenders after submitting the tender.
- 4.20 The successful tenderer should not engage persons below 18 years and above 50 years of age to do this work. If the successful tenderer engaged the persons below 18 years, the contract will be terminated.
- 4.21 It is the liability of the successful tenderer to pay statutory dues such as GST, EPF, ESI, etc., as per the rules in force. If any non-payment of statutory dues found in the previous work done by the successful tenderer, the contract will be terminated.
- 4.22 The reputation of the federation should not be tarnished.
- 4.23 The contractor should inform the old employees of leaving the job and the appointment of the new employees.

PAYMENT OF EMD:

- 4.24 The tenderer shall pay an EMD of Rs.73,000/-(Rupees Seventy three thousand only) by way of online payment only.
- 4.25 The EMD remitted by the tenderer shall be forfeited in full and the offer will be summarily rejected in the following contingencies.
- a. If the tenderer withdraws his offer or backs out before the expiry of the validity period or after acceptance of the tender.
 - b. If the tenderer revises any of the terms quoted during the validity period.
- 4.26 The successful tenderer alone is the sole employer and it is his responsibility to extract work from his employees conforming to the stipulations in this tender document. For any commission and omission on the part of his employees the successful tenderer alone is liable and the latter shall pay damages to the Federation for any damage / loss caused to the Federation by his employees.
- 4.27 There will be no employer- employee relationship between the employees of the successful tenderer and the Federation.
- 4.28 The successful tenderer alone is liable for implementation of all the labour laws applicable to his employees.
- 4.29 In case, by chance the Federation has to shoulder any liability arising out of any statutory provisions, the successful tenderer shall make good the loss in that regard to the Federation.
- 4.30 In case of any accident involving the employees of the successful tenderer the compensation and the penal consequences under the relevant Act shall be borne entirely by the successful tenderer. If the Federation has to incur any expenditure in that regard, the same shall be reimbursed by the successful tenderer.
- 4.31 The employees so engaged by the successful tenderer under no circumstances could be considered for appointment in the Federation on the ground that they have worked as a contract labourer.
- 4.32 The employees of the successful tenderer cannot claim any benefits or amenities extended to Federation employees.
- 4.33 All sums found due to the Federation under or by virtue of these presents shall be recoverable from the successful tenderer under the provisions of Tamilnadu Co-op. Societies Act 1983 or in any other legal manner as the Federation may deem fit, if the same could not be recovered by adjusting from the security deposit or the bills of the tenderer, due to any reason.

- 4.34 The Managing Director, TCMPF Ltd., Chennai reserves the right to split the tender and place orders on one or more tenderer. The Managing Director also reserves the right to reject any tender offer fully or partially without assigning any reasons thereof.
- 4.35 The successful tenderer, after the expiry of the contract period has to execute the work at the same rate, terms and conditions for a period up to 6 (Six) months from the date of expiry of the contract.
- 4.36 The successful tenderer should provide manpower having 600MT BDF Ammonia Refrigeration Plant operations experienced/Technical qualified operators with age between 25-50 years to this works.
- 4.37 The successful tenderer shall be responsible to the TCMPF for any loss or damage arising out of theft, burglary, pilferage, larceny, mischief, looting etc., due to the involvement or negligence of his/her workers and the successful tenderer shall make good any such losses or damages as ascertained by the Federation to the Federation and such losses are liable for deduction from his / her bills/deposits etc.
- 4.38 The Successful tenderer should furnish medical fitness certificates within 30 days from the date of taking over the job in respect of providing 6 Nos Manpower that they are not affected with any contagious diseases such requirement is necessary since they are handling the milk daily. Failing which the Federation will arrange for the medical checkup and certificates and the cost of expenditure incurred in such medical checkup will be recovered from the successful tenderer.
- 4.39 The Successful tenderer should execute the work as per requirement in the tender documents. If any lapse is noticed for more than 3 occasions, the Federation reserves the right to terminate the contract and the Federation would be at Liberty to call for new tender. This is in addition to recovering damages for the loss caused to the Federation by such lapses.
- 4.40 If the contract is prematurely terminated for lapses on the part of the tenderer to fulfill the terms and conditions or prematurely withdrawn by the successful tenderer, the Security Deposit is liable to be forfeited and if the amount of such loss is more than the security deposit the same will be recovered from the successful tenderer by legal means, apart from forfeiture of any amount due to the successful tenderer.
- 4.41 The successful tenderer should pay not less than the wages prescribed by the District Collector to his/her workers.

4.42 SECURITY DEPOSIT:

- 4.42.1 After evaluation and finalization of Part I Technical bids and Part II Commercial bids, selected tenderer shall furnish a Security Deposit amount at 5% of the order value (including EMD) for TWO years (2025-2027) drawn by means of Bank Draft from any scheduled / commercial Bank in favour of The Joint Managing Director, TCMPF Ltd., Chennai payable at Chennai within 15 days from the date of work order.
- 4.42.2 The EMD paid already along with the tender shall be adjusted against security deposit to be paid by the successful tenderer.
- 4.42.3 No exemption will be given from payment of Security deposit under any circumstances as per TNTT Act and the same should be remitted by Demand Draft only. Bank guarantee and any other form of remittance will not be accepted.
- 4.42.4 The security deposit is liable to be adjusted against any loss or damage caused by the tenderer to the Federation by his violation of the tender conditions.
- 4.42.5 The security deposit will be refunded only after the expiry of 6(Six) months from the date of satisfactory completion of the contract and satisfactorily complying with the scope of work and the conditions thereof.
- 4.42.6 No interest shall be paid on the earnest money deposit or security deposit.

4.43 AGREEMENT:

- 4.43.1. The successful tenderer should sign an agreement on a non-judicial stamp paper to the value of Rs.100/- within 15 days from the date of work order. Non execution of the agreement will lead to cancellation of work order and forfeiture of EMD.
- 4.43.2. If the successful tenderer fails to execute the contract satisfactorily at the tendered rate, the security deposit will be forfeited by the Federation.
- 4.43.3. If the Federation incurs any loss/ additional expenditure due to the negligence of the successful tenderer in connection with the work during the period of contract, the same shall be recovered together with all charges and expenses from the successful tenderer.

4.43.4. The losses or damages, if any , caused by the successful tenderer or his employees to the property of the Federation ,the cost as ascertained by the Federation will be recovered from the successful tenderer.

4.43.5 No increase in the rate will be allowed during the period of contract under any circumstances.

4.44 PAYMENT TERMS:

4.44.1 The successful tenderer shall submit necessary monthly bill in duplicate along with advance stamped receipt, performance report, copies of the EPF & ESI Challans of the previous month and monthly GST payment for making payments.

4.44.2 The payment shall be made within 30 days from the date of receipt of the bills based on attendance / performance of the work.

4.44.3 Income tax will be deducted from the monthly bill of the successful tenderer and the same will be remitted to the Income Tax Department.

4.44.4 It is the liability of the successful tenderer to pay GST as per the rules in force.

4.44.5 Loss or damage if any caused by the successful tenderer to the Federation shall be adjusted against the bill amount.

4.45 PENALTY:-

The following penalties will be imposed on the successful tenderer for the following lapses:-

- 1) Unsatisfactory work in up-keeping conditions as found out by the Federation, a fine of Rs.5000/- (Rupees Five thousand only) will be recovered.
- 2) "Providing 6 Nos manpower having 1 year Ammonia Refrigeration experienced ITI/Diploma/Refrigeration Technician qualified operators for Operation & Routine Maintenance of 600MT Butter Deep Freezer Ammonia Refrigeration Plant with H.S. Screw Compressor, Frick Vilter Two stage Compressors with all related equipment's with each 100MT Frozen Chamber-6 Nos SCADA operation system and maintain the temperature between(Minus) -15°C to -18°C & IRS plant routine maintenance cum shift reliever for TWO years contract period (2025-27) for round the clock operations from the date of awarding Contract at Ambattur Dairy" from the date of awarding Contract.

Noted and agreed to the above

- 3) In case the contractor failed to supply required manpower in any particular shift i.e., A, B or C shift as mentioned in the scope of work the wages of worker short the cost of wages per worker per shift will be recovered at the approved tender rate and a penalty of Rs.1,000/- (Rupees One thousand only) will be recovered.
- 4) Time being the essence of this contract no variation shall be permitted and if the tenderer fails to supply and execute the work in full or part of the order as per the work order, the Federation shall reserve the right to cancel the order besides forfeiting the Security Deposit.
- 5) If the successful tenderer defaults to execute agreement or to pay security deposit or to supply ordered quantity either in part or full shall be debarred from participating in the subsequent any tender for a period of 3 years.
- 6) Proportionate rate cut will be imposed for the late arrival of employees or late commencement of work.

4.46 **VIOLATION OF CONTRACT**

- 4.46.1 Not with-standing anything contained in the tender schedule, no obligation is cost on the Federation to accept the lowest tenderer and the Federation shall also have the right to accept or reject the tender. If the Tender Accepting Authority decides that the price quoted by the tenderer is higher than the prevailing Market Rate.
- 4.46.2 For violation of any of the Terms and conditions of the contract, the Federation reserves the right to terminate the contract.
- 4.46.3 Time being the essence of this contract, no variation shall be permitted. If the successful tenderer fails to despatch and execute the work in full or part of the work as per the work order, the Federation reserves the right to cancel the order besides forfeiting the security deposit and the resultant loss.
- 4.46.4 If the successful tenderer defaults to execute agreement or to pay security deposit or to execute the ordered quantity either in part or full shall be terminated from the contract and shall be debarred from participating in the subsequent any tenders for a period of 3 years in the federation and it's District Union Dairies. Besides, the existing contract works being carried out in the Federation and its Dist. Unions also will be terminated.
- 4.46.5 If the contractor is found to be blacklisted or terminated in any other contract with the Federation/District Unions, the Federation reserves the right to terminate the contract.

4.47 LIQUIDATED DAMAGES

4.47.1.If the bidder / Contractor fails in his due performance of the contract within the time fixed in the schedule accompanying the order or extension of time granted.

4.47.2Liquidedated damages will be levied at Rs.100/- per day for the number of days that the work has been delayed.

4.48 RIGHTS OF THE FEDERATION:

4.48.1.If the bidder fails to execute the work in full or part of the order as per the Agreement or Work order, the Federation shall reserve the right to cancel the order besides forfeiture of EMD/Security Deposit.

4.48.2.Notwithstanding anything contained in the tender schedule, no obligation rests on the Federation to accept the lowest tender and the Federation shall also have the right to accept or reject any or all the tenders fully or partly without assigning any reasons.

4.48.3.For violation of any of the terms and conditions of the contract, the Federation reserves the right to terminate the contract, with or without notice as applicable.

4.48.4.On termination of contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by legal means apart from forfeiture of any amount due to the contractor.

4.48.5.If the bidder defaulted in any of the previous tenders to execute agreement or to pay Security Deposit or to Work ordered quantity either in part or full will not be eligible from participating in this tender.

4.48.6.If the successful bidder either in Federation defaulted to execute agreement or to pay Security Deposit or to Work ordered either in part or full shall be debarred from participating in the subsequent tenders for a period of 3 years.

4.49 DISPUTES AND ARBITRATION:

In case of disputes arising out of this tender, an arbitrator as mutually acceptable to the bidder and Federation will be appointed by the Managing Director, TCMPF Ltd. The arbitrator's decision shall be final, conclusive and binding on both the parties.

4.50 LEGAL JURISDICTION

In case if either party to the tender is aggrieved by the award of the arbitrator so appointed as per clause 28.0 or otherwise, they can appeal to Court of Deputy Registrar (Dairying), Thiruvallur. The legal jurisdiction will be only Deputy Registrar (Dairying), Thiruvallur.

4.51 INSPECTION

The Federation officials may inspect the contract work at any time during the contract period. The Contractor has to assist the officials in report generation.
