#### 2.24. Sample - Sub clause - 2.24.1. :

2.24.1. The successful tenderer should submit their samples of Rolled Sugar Cone Biscuit with Sleeves allotted to them after the award of contract as per the delivery schedule prescribed by the Federation.

#### May be changed as

- 2.24.1. Tenderer should submit 20 Nos. of any flavor Rolled Sugar Cone Biscuit with Sleeves with any multicolor printed art work & matters on the Sleeves as per the specifications defined and demanded as samples for testing along with tender document before the closure date and time at etendering website "https://tntenders.gov.in". Failing of which will be liable for Summarily Rejection of the tender.
- 2.24.2. The samples has to be submitted to the Dy. General Manager (Engg.), Joint Managing Director's Office, TCMPF Ltd., Plot No.29 & 30, SIDCO Industrial Estate, Ambattur, Chennai 600 098 before the tender closure date and time for submission of tender through e-tendering website "https://tntenders.gov.in". If failed to submit the samples before the closure time and date of the e-tender, such tender offer will be summarily rejected.
- 2.24.3. The samples will be tested for the compliance with Specifications (Chapter 7). If the samples failed in the test, the tender offer concerned will be summarily rejected.

3.15.
