Engaging Vehicles on Quotation.

Terms and Conditions

Vehicles along with load men Requirement Details: -

➤ Purpose

To load the Milk Products with tubs/crates/containers, unload in various approved points and collect empties and cheques and to return to the dairy /control room..

➤ Type of vehicle

80mm thick PUF Insulated vehicles are required.

➤ Vehicle Capacity

Net carrying capacity not less than 2 MT. To carry milk products with tubs / crates / containers

➤ Distance

The distance will be calculated from the dairy dock to the various points and back to the dairy for the same route (Route Wise Distance given in the Quotation format) .

The distance mentioned is approximate and actual distance will be measured and the measured distance is final. Accordingly for the additional / less distance diesel cost alone will be paid/reduced.

For vehicles 10 km per litre / litre will be taken as diesel consumption per litre.

➤ Period

The requirement will be initially for TWO months that shall be extendable. The diesel escalation is not applicable for this period.

❖ Trips:

One trip per day. The vehicle has to be parked at 5.00 AM daily at the respective dairy dock.

❖ Original Documents

The lowest quoted offerer should produce all the original documents for verification. The vehicles and Documents should be with current validity.

General

Vehicles are required on _____ Morning 4.00AM at the respective dairies. Failure to produce the vehicle will attract penalty as decided by the Federation. The penalty amount will be not less than the additional amount incurred by the Federation. Subsequent non-production of vehicles will attract additional penalty including the cancellation of the contract and with hold of the transport bill.

EPF-ESI

Successful contractors should necessarily entertain the EPF-ESI coverage to the Vehicle crew.

On conformation, an agreement will have to be executed.
