- 4.2 The bidder should be an Owner/ FIRM in partnership/Co-operative societies of road milk tankers.
- 4.3 PART - I TECHNICAL BID, wherein the pre -qualification is based on various factors such as supply, capacity etc., suitability and eligibility of the bidder comes under PART - II of the tender.

- 4.18.1 The tender shall be accompanied by an EMD @ Rs.10,000/- (Rupees Ten Thousand only) per RMT, as Demand Draft drawn on a Nationalized Bank / Scheduled Bank in favour of " The Joint Managing Director, TCMPF LTD., " payable at Chennai. **IT SHALL BE ENCLOSED WITH THE PART - I TECHNICAL BID ONLY.**
- 4.18.2 The E - Tender, the EMD amount Rs. 10,000/- (Rupees Ten Thousand only) per RMT may be paid through online in TN e-Procurement portal.
- 4.18.3 **No other form of remittance shall be accepted.**
- 4.19 **Conditions of Exemption of EMD Payment**
- 4.19.1 The tenderer who claim exemption from payment of EMD under the G.Os., should submit the copy of the G.O.
- 4.19.2 In the absence of G.O. the tender will be summarily rejected.
- 4.19.3 No exemption clause found in the MSME guidelines (Ref: The National Industrial Classification 2008).
- 4.20 **FORFEITURE OF EMD:**
1. If the Bidder, for any reason, withdraws his offer (or) stipulates any conditions in his offer;
 2. If the bidder submits fresh offer/ revises offers in case of any omission subsequently after opening;
 3. If the bidder backs off before the expiry of validity period or after acceptance of Works Contract;
 4. If the bidder revises any of the terms quoted during the validity period.

4.21 **FLEXIBILITY TO OPERATE THE TANKER IN BETWEEN INTER UNIONS**

4.21.1 During the flush seasons/ emergency situations the tanker needy Union General Managers may send a requisition letter to the sister union General Managers to spare the non-operating tankers during the urgency periods in the approved tender rate.

4.21.2 The necessary request letter must be signed by the concern union General Managers and the same copy may be sent to the sister union General Managers through e-mail / hard copy.

4.22 **MODIFICATION AND WITHDRAWAL OF BIDS**

4.22.1 No Bidder shall be allowed to withdraw the tenders after submitting the tender.

4.22.2 A Bidder may submit a modified Tender before the last date for receipt of tender: Provided that where more than one Tender is submitted by the same Bidder, the lowest eligible financial tender shall be considered for evaluation.

4.22.3 No bid may be modified after the deadline for submission of Bids.

4.22.4 Bidders shall submit offers that comply with the requirements of the bidding documents, as indicated in the technical specifications. **"Alternatives will not be considered"**.

4.22.5 Communication to the unsuccessful Bidders will be sent after the communication is sent to the successful Bidders. **Within 60 days** from the date of the receipt to refund vouchers duly stamped and signed from the unsuccessful Bidders, refund of Earnest Money Deposit will be made.

4.23 **ENCLOSURES:**

The bidder should submit the following documents duly self attested along with the Part - I technical bid

4.23.1 Work orders as supportive documents to show the past supply having supplied road milk tankers on contract basis to any of the reputed dairies.

4.23.2 Photostat copies of

4.23.3 The R.C. Books of the RMTs shall be in the name of the bidder in the case of sole owner. If the bidder is in any partnership in force, R.C. Book shall be in the name of either the firm or one of the partners and in the case of companies the R.C. Book shall be in the name of the firm (or) in the name of Director (or) duly authorized person on behalf of the company. In the case of Co - Operative societies, the RC book shall be in the name of the member of the society.

4.23.5 The bidder should enclose the copy of the deed / agreement or other documentary evidence under statute to show that he is the sole owner/ Partner of a firm/ Director / member of Co-Operative society.

4.23.6 The documents submitted should be genuine and reflect the correct position as the tender accepting authority is guided by the documents filed by the bidder. If any document of the successful bidder is found to be bogus or false, apart from terminating the contract penal action will be taken by collecting liquidated damages from the bidder.

4.24 **AGE OF THE ROAD TANKER:**

The RMTs shall be in the road worthy condition and its age must be less than 11 years (Eleven) as on the date of publication of notice inviting tender. The age of the vehicle will be calculated from the date of first registration of the RMT.

4.25 **SECURITY DEPOSIT**

Each successful Bidder, before execution of the agreement shall furnish a Demand Draft from a Nationalized Bank / Scheduled Bank drawn in favour of the General Manager of the concerned Union payable at places specified, at the rate of Rs. 75,000/- per 9000 Litre, Rs. 1,00,000/- per 15000 Litre &Rs. 1,25,000/- per 20000 Litre RMT as Security Deposit to the Union or the successful bidder shall furnish irrevocable bank guarantee for a period of three years for the above security amount value. In the event of extension of contract period, the successful Bidder shall extend the bank guarantee period to the extent of extension of contract period. The EMD paid shall be adjusted against the Security Deposit payable to the Union.

No exemption will be given from payment of Security Deposit under any circumstance as per TTI Act and the same should be remitted by Demand Draft/ Bank guarantee. Any other form of remittance will not be accepted. The security deposit will be refunded only after 6 months from the date of satisfactory completion of the contract satisfactorily complying with the production of original receipt.

- 4.25.1 No interest will be paid on the Security Deposit.
- 4.26 **AGREEMENT:** The successful Bidder shall execute an agreement with the Concerned Union General Managers with Rs.100/- valued Non-judicial Stamp Paper incorporating the terms and conditions of the contract within fifteen days from the date of intimation of the acceptance of the tender.
In case of default of either of the conditions (i.e) remitting the security deposit or execution of the agreement within the time allowed, the EMD paid is likely to be forfeited.
- 4.26.1 If the contractor fails to execute the contract satisfactorily at the tendered rate, the security deposit will be forfeited.
- 4.26.2 If the Union incurs any loss / additional expenditure due to the negligence of the contractor in connection with the work during the period of contract, the same shall be recovered together with all charges and expenses from the contractor.
- 4.26.3 The breakages or damages, if any, caused by the contractor to the property of the Union/Federation, the cost will be recovered from the contractor.
- 4.26.4 No interest shall be paid on Earnest Money Deposit/Security Deposit.
- 4.27 **PAYMENT TERMS:**
- 4.27.1 Payment will be made against claims along with the necessary documents like duplicate copy of Acknowledgement Weighment slip, Trip sheet, Toll gate fee receipts in original if paid in cash, if FASTag online transaction or GPS based toll fee payment transaction printout copy self-attested should be enclosed during the time of bill submission.
- 4.27.2 Such payment will be made within 30 days from the date of such claims (Without corrections) by the contractor excluding the deductions / penalties / recoveries / statutory deduction as applicable.
- N.B. NO OTHER TERMS OF PAYMENT WILL BE ENTERTAINED.
- 4.28 **PENALTY CLAUSE:**
- 4.28.1 Notwithstanding anything contained in the tender schedule, no obligation rests on the Federation to accept the lower tender and the Federation shall also have the right to accept or reject any or all tenders fully or partly without assigning any reasons.
- 4.28.2 For violation of any of the terms and conditions of the contract, the concerned Union reserves the right to terminate the contract, with or without notice as applicable.
- 4.28.3 On termination of contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by legal means apart from forfeiture of any amount due to the contractor.
- 4.28.4 (a) If the tenderer has defaulted in any of the previous tenders within a period of three years to execute agreement or to pay Security Deposit or to supply ordered quantity either in part or in full will not be eligible from participating in this tender.

Noted and agreed to the above

(b) If the successful bidder either in TCMF or in the DCMPU defaulted to execute agreement or to pay Security Deposit or to supply ordered quantity either in part or full shall be debarred from participating in the subsequent tenders for a period of three years.

4.29 **FORCE MAJEURE:**

Failure or delay in the part of contractor for operation of tankers due to force majeure causes enumerated here under shall be considered, provided the supplier produces documentary evidence.

- a. Any cause which is beyond the reasonable control of the contractor.
- b. Natural phenomena, such as floods, drought, earthquakes and epidemics.
- c. Act of any Govt. Authority, domestic or foreign, such as wars declared or undeclared quarantines, embargoes licensing, control on production or distribution restrictions.
- d. Accident and disruptions such as fire, explosion, increase in power cut with respects to date of tender opening etc.,
- e. Strikes, slow down and lockouts.

The cause of force majeure condition will be taken into consideration only if the supplier notifies within 30 days from the occurrence of such eventualities. The purchaser shall verify the facts and grant such extension as the facts justify. For extension due to force majeure conditions, the supplier shall submit his representation with documentary evidence for scrutiny by the purchaser and the decision of the purchaser shall be binding at the time.

4.30 **DISPUTES AND ARBITRATION:**

In case of disputes arising out of this tender, an arbitrator as mutually acceptable to the bidder and Federation will be appointed by the Managing Director, TCMF Limited. The arbitrator's decision shall be final, conclusive and binding on both the parties.

4.31 **LEGAL JURISDICTION**

In case if either party to the tender is aggrieved by the award of the arbitrator so appointed as per clause 4.30 or otherwise, they can appeal to Court of Deputy Registrar (Dairying), Thiruvallur. The legal jurisdiction will be only Deputy Registrar (Dairying), Thiruvallur Court.

4.32 **FINALIZATION OF TENDER**

4.32.1 After opening the Technical Bid, the eligible bidders will be called for the commercial Bid opening.

4.32.2 The Bidder shall quote his rate which shall include all operating expenses (direct and indirect), permit charges, wages, vehicle insurance, Cargo insurance etc. for transporting 9000 Litre, 15000 Litre & 20000 Litre of milk.

4.32.3 The price of diesel prevailing at "M/s. IOCL retail outlet in the name of Aavin Fuel Station", Ambattur Industrial Estate, Chennai on the date of publication of notice inviting tender will be taken for evaluation of the rate offered by the bidders.

Noted and agreed to the above

4.32.4 The rates quoted will remain firm throughout the period of contract. Once the contract is awarded to the bidder, the charges payable to the tender for the work extended will be only at the rate accepted and finalized by the Federation. Even during extension of contract period, the bidder will be paid same tender approved rate. The bidder cannot claim any extra amount on this account.

4.32.5 However the contract rate will be adjusted for any variations in the price of diesel occurring subsequent to the date of publication of notice inviting tender. The increase/decrease in rate will be based on MRP of HSD sold by public sector oil companies, in M/s. IOCL retail outlet in the name of Aavin Fuel Station", Ambattur Industrial Estate, Chennai and mileage will be calculated as follows

9000 Litre - 5.00 KM per Litre / HSD

15000 Litre - 4.75 KM per Litre / HSD

20000 Litre - 4.50 KM per Litre / HSD

4.32.6 At Federation level: The Managing Director is vested with the right to finalise the rates. The successful Road Milk tankers are allotted by the Managing Director to the District unions based on their request of RMT quantities and capacities.

4.33 **TOLL GATE CHARGES:**

While quoting the rates in the Part - II Commercial Bid, the Toll rate charges shall be excluded.

4.34 **PARTNERSHIP DEED:**

Tenders will be accepted from Partnership firms only if there is a Partnership deed between the bidders. The Partnership deed entered into by the contractors and registered with the Govt authorities must be attached with the technical bid .

4.35 **INSPECTION OF ROAD MILK TANKERS:**

4.35.1 RMTs are subject to inspection by the General Manager of the Union or by any Officer authorized/nominated by him at any time. Maximum time allowed for producing the allotted vehicle by the successful Bidder is 15 days from the date of receipt of Work order. If any defects are noticed at the time of producing the vehicle, the same will have to be rectified by the successful Bidder within 7 days.

4.35.2 If the RMTs provided by the Contractor are in bad condition / found to be unfit for milk transportation it shall be disengaged and the bidder shall make immediate alternative arrangement for milk transportation so as to avoid any dislocation in milk movement.

4.35.3 The successful bidder should provide only road-worthy vehicles for the contractual work. In case of development of sudden defect, the Contractor should get the vehicle repaired immediately.

4.35.4 In case of plying of such defective vehicle the contractor should immediately inform the Union and the bidders will be paid hire charges less by 5% per trip till it is rectified. However such vehicle should not be used beyond 15 days. If such vehicle are used beyond 15 days, the contract of that vehicle will be terminated, forfeiting the Security Deposit and levying liquidated damages.

Noted and agreed to the above

- 4.35.5 In case the Contractor could not discharge his contractual obligation because of the above reason and also could not make alternative arrangement for uninterrupted work of transportation of milk, the Union would levy penalty and additional damages for such failure of the tenderer.
- 4.35.6 The contractor shall display the following items in size specified by the Federation on the tankers at their cost.
- i. 'On Contract' with the concerned DCMPU Ltd., name on both the sides of tanker
 - ii. Contractor's name and mobile number.
- 4.35.7 The Bidder should remit Rs.10/- and become the associate member of the Union on awarding of the contract. The amount will not be refunded and the bidder is not eligible for participating in election or getting the profit.
- 4.35.8 The employees of Federation / District Co- Operative Milk Producers' Union / Milk Producers' Co-Operative Society / Milk Consumers Co-Operative Society / Dairy Development Department or their family members cannot participate in the tender in any form.
- Here, the term "Family member" means, Spouse, Father, Mother, Brother, Sister, Son, Daughter, Grand Father, Grand Mother, Son in Law, Daughter in Law, Grandson and Grand Daughter.
- 4.36 **TRANSIT INSURANCE:**
The Contractor shall arrange for insuring the cost of milk transported in the RMT (Cargo Insurance). The loss sustained to the Union on account of spoilage of milk due to delays in transportation, variance in quality / quantity of milk transported due to tampering of seal and other damages occurring to the property of the Union, milk societies etc., due to the negligence of the Contractor or his crew, will be recovered from the Contractor.
- 4.37
- i. The Union reserves the right to allot the route to be operated from anyone of the Dairy / Chilling Centers / BMC Centers / other states as and when necessitated for un-interrupted transportation of milk. The routes and the number of BMCs attached are liable to be changed by the General Manager / authorized officers of the Union in case of exigencies and it will be the bounden duty of the bidder to follow the directions. In such cases, the bidder will be paid transportation charges at the approved rate applicable for the said routes.
 - ii. The RMTs shall not be used for transporting any item including milk for other Unions / Organizations during their return trip. If any vehicle is found indulging in these activities the contract will be terminated without giving notice.
 - iii. The allotted RMTs shall be used for the purpose of milk transportation of the Union only. No person other than the driver, attender and the authorized employee of the Union shall be allowed to travel in the RMTs within the permissible limit prescribed in the MV Act and rules.

Noted and agreed to the above

OBLIGATIONS OF THE CONTRACTOR :

- a) The RMTs shall be ready for operation for the entire period of contract other than for F.C. repairs for which a maximum of 15 days will be given for getting F.C. During the period of F.C. repairs the bidder is duty bound to provide alternate tanker and to ensure that there is no interruption of the scheduled operations. During the period when the permission was availed by the bidder to garage the RMT, the bidder should ensure uninterrupted contractual operations by providing substitute RMT conforming to all specifications stipulated in the tender document. There should be no deficiency in service or damage on any count, because of engaging substituted vehicle. In the absence of such substituted vehicle while the contracted RMT is arranged, the bidders shall pay to the Union the loss if suffered by the Union plus a fine of Rs.1000/- per day. The request of Contractor seeking permission to garage the RMT for a period up to 30 days for carrying out fitness certification job will be considered only if the requests are received at least 30 days in advance.
- b) The allotted RMT's shall not be sold / disposed off or leased out to others during the contract period. However the bidder is permitted to sell / dispose the allotment RMT during the contract period after getting prior permission from the General Manager of the Union, provided he offers an alternative RMT of similar capacity and age lesser than the tendered RMT.
- c) The bidder shall not involve in the sale of milk or milk products either directly or indirectly.
- d) The bidder shall provide replacement of tendered RMT in case of accident and unforeseen circumstances. In the event of accident/ breakdown en route, it is the responsibility of the successful tenderer to make alternative arrangements to decant milk from RMTs and transport milk safely to the destination. During this process there should not be any wastage or spoilage of milk. In case of wastage/ spoilage due to the above event, the loss will be recovered as assessed by the Union from the Contractor.
- e) In the above events, the bidder shall provide replacement for tendered RMT of same capacity. If higher capacity vehicles are provided, the rate applicable for the tendered vehicle alone will be paid.
- f) The successful bidder should operate the RMT in case of necessity as per the agreement beyond tender period up to the time permitted by the TTI Rule 14 (9), at the same rate, terms and conditions.
Rule 14 (9) : The tender documents shall indicate the quantity proposed to be procured in the tender, and the Tender Accepting Authority shall be ordinarily permitted to vary the quantity finally ordered only to the extent of twenty five percent either way of the requirement indicated in the tender documents.
- g) The bidder shall arrange to provide the required number of additional RMTs within the limit permitted in the TTI Rule 14 (9) at required time and at required place as per the direction of General Manager of the Union or his authorized representative at the same contract rate only.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

Rule 14 (9) : The tender documents shall indicate the quantity proposed to be procured in the tender, and the Tender Accepting Authority shall be ordinarily permitted to vary the quantity finally ordered only to the extent of twenty five percent either way of the requirement indicated in the tender documents.

h) The bidder shall arrange to provide the required number of additional RMTs within the limit permitted in the TTI rule 14 (9) at required time and at required place as per the direction of General Manager of the Union or his authorized representative at the same contract rate only.

4.39 GLOBAL POSITIONING SYSTEM (GPS):

a) The concerned Unions may fix and maintain GPS instrument with electronic locks in all Road Milk Tankers (RMT).

b) The contractors should not tamper or damage the GPS instrument with electronic locks, if it is tampered or damaged, then the penalty clause will be invoked.

c) The Road Milk Tanker will be engaged only if the GPS instrument with electronic locks is functioning.

d) The contractor should not operate the vehicle, if GPS instrument with electronic locks does not function or is malfunctioning.

e) The above GPS clause will come into force from the date of commissioning the GPS instrument with electronic locks.

4.40 PENALTY CLAUSE FOR BREAKDOWN OF GPS INSTRUMENTS:

a) If the GPS instrument with electronic locks is damaged, double the cost of the GPS instrument with electronic locks will be recovered as penalty from the contractor besides disengaging the vehicle crew permanently.

b) If the above lapse is repeated for second time, the contract for the above Road Milk Tanker (RMT) will be suspended for 45 days, besides imposing penalty as mentioned above.

c) If the above lapse is repeated for third time, the contract for the above RMT will be terminated permanently without giving any notice.

d) If the GPS instrument with electronic locks is removed from the RMT, damage to the antenna, removal of main battery wire, damage to SIM Card etc., or any other incidence which leads to non - functioning of GPS instrument with electronic locks will attract a penalty of Rs, 2,000/- to the contractor for the first occasion and Rs. 5,000/- for the second occasion besides disengaging the vehicle crew permanently and the Union reserves the right to terminate the contract permanently without giving any notice.

4.41 DELAYED PARKING:-

Failure in parking the vehicles at the appropriate time at the loading dock will attract penalty of 10% of the hire charges in addition to making good the loss if any occurred to Union in this regard by recovering from the contractor

Noted and agreed to the above

SIGNATURE OF THE BIDDER

4.42 FSSAI CERIFICATE:

The FSSAI Certificate from the competent authority must be provided by the successful bidder within one month from the date of award of the contract. This Certificate must be valid throughout the period of contract and it is the responsibility of the contract or to renew the certificate Periodically on his own cost.

4.43 LIABILITY OF THE CONTRACTOR TOWARDS HIS EMPLOYEES:

- a) The relationship between the Union and the Contractor is one of principal to principal and not one of principal to agenda.
- b) The Contractor is obliged to discharge the contractual obligation by engaging his own men and materials. The Union will have no connection whatsoever with the men engaged by the bidder.
- c) UNIFORM TO VEHICLE CREW: The contractor shall provide Khaki uniform and ID Card to the employees and it is the duty of the contractor to ensure that they wear uniform while they are on duty, failing which a penalty of Rs. 500/- per day per employee will be recovered from the claims.

4.44 PRECAUTIONS TO BE TAKEN WHILE SUBMITTING THE DOCUMENTS:

1. Tender forms containing over - written rates, erased rates not shown in words will be rejected.
2. In case of discrepancy in rates as shown in figures, and in words, the tender accepting authority will take the lower of the two.
3. The bidder shall sign in every page of the tender document and shall ensure the document is complete in all respects.
4. The bidder must satisfy himself thoroughly about the geographical area to be covered, nature of work, local conditions and the requirement of the Federation before submitting his tender.
5. The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document. In the latter case, authorization letter should be attached.

4.45 BLACKLISTED APPLICANTS:

If the tender has already been blacklisted by any Government / Government Under takings Other Unions of the Federation / Co - Operative societies, his tender will be summarily rejected. In case information about such black listing comes to the knowledge of the Federation after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.

Noted and agreed to the above

4.46 VALIDITY OF TENDER:

The tender offer shall be kept for acceptance for a period of 90 days from the date of opening of Part - I Technical bid. The offers with lower validity period are liable for rejection.

4.47 DEVIATION FROM TENDER CONDITION:

- a) The offers of the bidders with deviations on technical / commercial terms of the tender will be rejected.
- b) No alternate offer will be accepted.
- c) Conditional offer will be rejected.

4.48 DISQUALIFICATION CLAUSE:

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- a) Made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and/ or
- b) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc... and /or
- c) Participated in the previous bidding for the same work and had quoted unreasonably high bid prices and could not furnish rational justification to the employer.
- d) Those bidders who have been blacklisted by other unions and the period of such blacklisting is in force during the tender evaluation period are deemed to be disqualified from participating in the tender.

4.49 MISCELLANEOUS:

- a) The Managing Director of the Federation reserves the right to add, subtract and modify any terms and conditions of the agreement with the Contractor during the contract period.
- b) The Federation reserves right to accept or reject any or all tenders, retender or cancel the tender as per provisions of TTI Act and Rules.
- c) Quality of service and time are the essence of the tender. The time schedule for the operation of RMTs, will be given by the Union for which applied for and the RMTs should be operated scrupulously following the time schedule, as any delay in same would cause loss, damage and impairment of quality of milk supplied by the Union.
- d) The authorities of the Union for which tender applied for may inspect the RMTs of the successful bidder. After inspection, if any suggestion is given for improvement, upkeep or maintenance or replacement of parts, the same should be carried out by the successful bidder.
- e) If the authorities of the Union demand any record like Log Book. Trip sheet, R.C. Book, Insurance certificate, etc., the same should be produced without delay.
- f) The Tanker will be permitted for operation as per motor vehicles act and rules.
- g) All offered Road Milk Tank lorries must have Locking / sealing arrangement facilities as per company's norms for locking / sealing the loaded tank lorries with the product.

Noted and agreed to the above

h) Where the loading / Unloading locations are situated within the same State and sections where axle load restrictions are imposed, they shall supply trucks meeting axle load restrictions and permit for intrastate and interstate supplies.

i) The Road Milk tankers offered in the contract must comply at all times during the tenure of the contract with valid permits, rules and regulations of Statutory / Government authorities.

j) Federation will have the right to assign the Road Milk Tankers offered in any one tender to any contract in any other State/ Region /Location, on any route, temporarily or permanently, and the decision of Federation/ Union General Manager will be final and binding on the successful bidders / contractors.

k) If any of the information submitted by the bidder is found to be incorrect at any time including the contract period, Federation reserves the right to reject the tender / terminate the transportation contract and reserves all rights and remedies available.

The above rate per Km is inclusive of all charges.

Whereas the contractor had accepted to transport milk through his **stainless steel insulated RMTs of capacity 15000 Litre approved by the Union for a period of three years commencing from at Rs..... (Exclusive Toll Fee as on date) (.....) per KM** to and fro for 15000 Litre as per the terms and conditions of the tender. The above rate per Km is inclusive of all charges.

- (2) The contractor should operate the RMT in case of necessity as per the agreement beyond tender period up to the time permitted by the TTI rule 14(9), at the same rate, terms and conditions.

The RMT will be inspected by the Union whenever found necessary and the findings of the inspecting officer of the Union will be communicated to the contractor and the same must be rectified immediately not later than 3 days. The contractor will be paid hire charges less by 5% per trip till it is rectified. However such vehicle should not be used beyond 30 days. Any failure on the part of the contractor in this regard will result in removal of RMT from operation.
- (8) When a RMT is removed in the contingency specified above, the contractor shall immediately replace the vehicle, which should conform to the specification in the contract. Failure in this regard will result in termination of the contract of that RMT apart from forfeiting the security deposit and levying liquidated damages.

- (16) The substitute or replacement of spare RMT should also be got approved by the General Manager or by the duly authorized person of the Union.
- (17) The milk tanks of RMTs shall be stainless steel conforming to BIS specification (inner shell - AISI 304 grade). It should keep the milk without spoilage. The milk tank should be insulated to ensure that the temperature rise limit shall not be more than 2°C in 24 hours during transportation.
- (18) RMTs shall have proper manhole and valve sealing mechanism for safe transportation of milk in good condition.
- (19) Any deviation from the specification to the disadvantage of the quality of RMT would entitle the union in taking penal action on the contractor, including termination of contract.
- (20) In case milk transported by the contractor is spoiled due to any failure or lapses or deficiency in providing the above stated requirement, the contractor should make good the loss as ascertained by the Union, apart from facing the penal action that may be taken against him under the contract.

Arrival and departure of the RMT will be recorded at the main gate of the Dairy or Chilling Centers / BMCs by security guard / staff. The RMT driver should ensure the time entries made in the route schedule.
- (27) The driver of the RMT and other attending person, if any should adhere to the rules and regulations of the Union besides following all the safety regulations.
- (28) The driver and attender should remain only in allotted place and they shall not wander inside the premises of the Union.
- (29) The driver and attender should subject themselves for security check, if required.

If the milk transported by the contractor is found adulterated and certified by the quality control authorities at the destination in this regard, the contractor is liable for all the penal consequences besides recovery of the cost of milk so adulterated and the tanker crew will be disengaged permanently. If adulteration is repeated, it will result in blacklisting of the contract of the RMT.
- (50) The allotted RMTs shall be used for the purpose of milk transportation of the Union only. No person other than the driver, attender and the authorized employee of the Union shall be allowed to travel in the RMTs within the permissible limit prescribed in the MV Act.

PAYMENT OF BILLS

- (51) The transport charges will be paid on kilo meter basis for a tanker capacity of 9,000 litres and 15,000 litres (To and Fro) on the shortest route as approved by the Union and no other charges will be paid other than kilo meter charges. However, the contract rate will be adjusted for any variations in the price of diesel occurring subsequent to the date of publication of notice inviting tender. The increase/decrease in rate will be based on MRP of HSD sold by "M/s. IOCL retail outlet in the name of Aavin Fuel Station", Ambattur Industrial Estate ,Chennai and mileage will be calculated as follows
1. 9000 Litre - 5.0 KM per Litre
 2. 15000 Litre - 4.75 KM per Litre
 3. 20000 Litre - 4.50 KM per Litre
- (52) Further, the contractor will be compensated for any hike in toll charges or levying of toll fee in the wake of opening of new toll gates subsequent to the award of the contract. The contractor should furnish the relevant toll fee receipts to the Union for claiming reimbursement.
- (53) In case of transporting milk from or to other States the additional expenditure incurred by the contractor in getting permit etc; will be reimbursed against the bills with the evidence of such expenditure obtained from the respective State Government authorities.
- (54) If higher capacity vehicles are provided as substitute RMTs, the rate applicable for the tendered vehicle alone will be paid.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

- (55) Payment for the transport bills will be paid on fortnightly basis. The contractor shall submit bills within three days of the completion of the fortnight. All applicable statutory deductions will be made from the bill. The payment will be made within 15 days from the date of receipt of the bill based on the satisfactory performance of the work.
- (56) Recoveries due to shortage of milk in transit and other violations as per the agreement and tender conditions will be made from the bills directly.
- (57) The details of recoveries will be sent along with the payment. Representation on such recoveries and penalties if any by the contractor should be submitted to the General Manager of the Union within 15 days from the date of receipt of respective bill amount. No such representation will be entertained there after.
- (58) In respect of any penalty / liquidated damage imposed by the Union for violations of the provisions of the contract by the contractor, the same will be recovered from the bills payable to contractor. If there is any excess penal amount to be recovered the same will be adjusted against the subsequent bills / Security Deposit.
- (59) The contractor is liable for implementation of all applicable laws including labour laws. The contractor shall register under the EPF Act, and ESI Act etc., the contractor shall furnish the copy of EPF & ESI remittance challans of the previous month towards contribution of EPF & ESI for their employees engaged in Road Milk Tankers along with the second fortnight bill. Without this proof, the second fortnight bill will not be accepted. If the Contractor not registered under the EPF Act, and ESI Act or not furnished the proof of remittance of EPF & ESI, the Union shall recover the EPF & ESI contribution from the contractor bills. The contractor shall furnish all the required information and documents whenever the Union calls for the above purpose. If any liability devolves on the Union because of the failure of the contractor in implementing any law, the contractor shall make good the loss and pay damages to the Union.

OTHER WRONGFUL ACTS AND PENALTIES

- (60) If the RMT does not adhere to the scheduled timings as given by the Union from time to time a penalty of Rs.1,000/- per occasion shall be deducted from the hire charges of the contractor. If there is recurrence of failure to adhere to schedule, the Union will terminate the contract and impose liquidated damages.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

(61) If the milk is found to be spoiled due to late arrivals of the RMTs at the chilling center / BMC Centers / Dairy or metro dairies or non collection of milk from the supply point, the cost of such quantity of milk in question will be recovered from the contractor. If such instances are repeated, the Union will terminate the contract and impose liquidated damages.

(61) (a) Global Positioning System (GPS)

- (i) The Union will fit and maintain GPS instrument with electronic locks in all Road Milk Tankers (RMT).
- (ii) The contractors should not tamper or damage the GPS instrument with electronic locks, if it is tampered or damaged, then the penalty clause will be invoked.
- (iii) The Road Milk Tanker will be engaged only, if the GPS instrument with electronic locks are functioning.
- (iv) The contractor should not operate the vehicle, if GPS instrument with electronic locks does not function or is malfunctioning.
- (v) The above GPS clause will come into force from the date of commissioning of GPS instrument with electronic locks.

(61) (b) Penalty Clause for breakdown of GPS instruments:

- (i) If the GPS instrument with electronic locks is damaged double the cost of the GPS instrument with electronic locks will be recovered as penalty from the contractor besides disengaging the vehicle crew permanently.
 - (ii) If the above lapse is repeated for second time, the contract for the above Road Milk Tanker (RMT) will be suspended for 15 days, besides imposing penalty as mentioned above.
 - (iii) If the above lapse is repeated for third time, the contract for the above RMT will be terminated permanently without giving any notice.
 - (iv) If the GPS instrument with electronic locks is removed from the RMT, damage to the antenna, removal of main battery wire, damage to SIM Card etc., or any other incidence which leads to non - functioning of GPS instrument with electronic locks will attract a penalty of Rs. 2,000/- to the contractor for the first occasion and Rs. 5,000/- for the second occasion besides disengaging the vehicle crew permanently and the Union reserves the right to terminate the contract permanently without giving any notice.
- (62) In the event of not providing RMT by the contractor at the specified point, leading to spoilage of milk, double the cost of milk will be levied as penalty. The amount of overhead charges that accrues to the Union or supplier will also be recovered from the contractor.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

DELAYED PARKING

- (63) Failure in parking the vehicles at the appropriate time at the loading dock will attract penalty of 10% of the hire charges in addition to making good the loss if any occurred to Union in this regard by recovering from the contractor.

BREAK DOWN

- (64) The sudden stoppage of RMTs due to accident or mechanical failure or any other causes necessitating the Union to arrange substitute RMT will be considered as failure of the contractor for the purpose of imposing penalty as decided by the Union.
- (65) In case the contractor fails to collect milk from any of the supply points due to break down etc. and if the Union make alternate arrangement to transport milk to the metro dairy/ nominated place, the cost of transport and quantity of milk declared as unfit and any other losses that may occur consequently will have to be borne by the contractor.
- (66) It will be the responsibility of the contractor to make alternate arrangement for the transportation of milk in the event of any break down and ensure safe arrival for the milk at the destination. Any loss arising out of such breakdown or accidents or unforeseen circumstances like strike, bandh etc. will have to be borne by the contractor.
- (67) The RMTs should not be taken outside the premises without the permission of the Union failing which a penalty of Rs.1,000/- (Rupees One thousand only) per occasion will be imposed.

WILFUL BREAK DOWN OF RMT:

- (68) In case any wilful breakdowns of the RMT is noticed, it will be deemed that the contractor has failed to provide the RMT, apart from recovery of actual transport cost of the trip Rs.1000/- per occasion will be imposed as penalty.

SELF STARTER

- (69) It is the responsibility of the contractor to keep the self starter in good condition. The non functioning of self starter, will attract a warning for the first occasion and a penalty of Rs.500/- (Rupees Five hundred only) for each occasion thereafter.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

CONTINUOUS BREAKDOWN:

- (70) If the RMT breaks down more than two times in a fortnight it will be disengaged from operation and reengagement of such RMTs shall be made only after conducting re-inspection by the Union. The loss arising on account of such disengagement as ascertained by the Union shall be borne by the contractor.

MAINTENANCE OF VEHICLE IN HYGIENIC CONDITION.

- (71) It is the responsibility of the contractor to provide the tanker in hygienic condition for transportation of milk. Non maintenance of tanker in hygienic condition will attract a warning for the first occasion and a penalty of Rs.1000/- (Rupees one thousand only) for each occasion will be levied there after.

PENALTIES DUE TO THE IRREGULARITIES COMMITTED BY THE TANKER CREW:**(72) Deviation of Routes and Unauthorized stopping:**

The RMT should ply normally on the route allotted to it. If the RMT plies in a route other than the routes specified, it will be regarded as deviation from the route. If the RMT stops on any point other than it is intended except due to mechanical trouble and traffic obstructions it will be treated as unauthorized stopping. Such deviation of routes or unauthorized stopping will entail a penalty of Rs.500/- (Rupees five hundred only) for the first occurrence and for subsequent such occasions an additional penalty of Rs.100/- (Rupees one hundred only) per occasion will be imposed progressively.

(73) Sale of milk by the vehicle crew direct from the RMT itself:

It is the responsibility of the contractor to arrange for the correct delivery of milk at the point of destination. In case of, the vehicle crew is found selling milk from the RMT directly, the RMT will be terminated, besides levying liquidated damages.

CARRYING OF EXCESS MILK:

- (74) It is the responsibility of the contractor to take delivery of milk loaded in the RMT at the Dairy dock before the actual dispatch of the RMT duly verifying the correctness of the quantity loaded in the RMT. Any milk found over and above the quantity as per dispatch schedule will be treated as "Excess Loading". If at the time of the RMT being loaded at the Dairy premises or at the Security Gate or later any excess quantity of milk is found, the value of such excess quantity will be recovered from the contractor at double the cost besides disengaging the vehicle crew permanently by the contractor.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

REFUSAL TO PRODUCE THE DESPATCH NOTE

(75) The vehicle crew should produce the dispatch note and other documents to the Officers at the time of inspection on demand. Failure or refusal to produce the delivery schedules and connected documents to the inspecting officers will attract a penalty of Rs.500/- (Rupees Five hundred only) for each occasion.

THEFT OF MILK / PROPERTY OF THE UNION:

(76) No RMT should carry the products other than those items as per dispatch note. In case any material is found taken / stolen away by the contractor / vehicle crew a penalty of Rs.1000/- (Rupees One thousand only) will be imposed for each such occasion apart from taking legal action against the person involved. In addition, the concerned RMT will be disengaged for 15 days. The vehicle crew will be disengaged permanently.

NON-PRODUCTION OF IDENTITY CARDS / DRIVING LICENSE TO THE INSPECTING OFFICERS:

(77) The vehicle crew should produce the identity cards and driving license whenever demanded by the Inspecting Officers of the Union. Failure to produce the identity cards and driving license will attract a penalty of Rs.500/- (Rupees five hundred only) per occasion. The vehicle crew will be prohibited from entering the Dairy premises without identity card and driving license.

MIS-BEHAVIOR OF VEHICLE CREW

(78) The vehicle crew (or) any employee of the contractor found drunk while on duty will not be allowed to ply in the RMT / to be in the dairy premises. The RMT crew should behave politely and gently. If the Union reports about mis-behaviour/ misconduct / involvement in case of adulteration or any other misconduct of the RMT crew, such persons should be disengaged immediately by the contractor and the fact should be informed to the Union. For this purpose name of such disqualified persons will be displayed at the Security point at the Dairies. Any violation in this regard will attract a penalty of Rs.500/- (Rupees five hundred only) per occasion to the contractor.

GAMBLING/ PLAYING CARDS IN THE DAIRY PREMISES:

(79) No gambling / playing cards by tanker crew should take place in the dairy premises. Any violation in this regard will attract a penalty Rs.500/- (Rupees five hundred only) per head per occasion.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

REFUSAL TO TAKE THE RMT:

- (80) No driver should refuse to operate the RMT either from the Dairy premises or elsewhere. A penalty of Rs.500/- (Rupees Five hundred only) will be levied on the contractor for the first occasion and for subsequent such occasion the vehicle crew will be disengaged.

INSTIGATION FOR SUDDEN STOPPAGE OF RMT:

- (81) No quarrel / any untoward incident should take place inside the dairy premises either by a vehicle crew or by mobilization of the crew of other RMT. If any attempt / instigation by the particular vehicle crew with the other contractor or vice versa then the vehicle crew responsible for such misdeed shall be disengaged and may also lead to termination of the contract.

CARRYING OF UNAUTHORIZED PERSONS IN THE RMT:

- (82) The vehicle provided by the contractor should not carry any unauthorized person. If lapse in this regard is noticed a penalty of Rs.500/- (Rupees Five hundred only) per head will be levied at the first instance and Rs.1000/- (Rupees Thousand only) per head thereafter.

UNAUTHORIZED CHANGE OF PERSONS IN THE RMT:

- (83) No change of persons (vehicle crew) will be allowed en-route. If any change of vehicle crew is noticed en-route it will attract a penalty of Rs.500/- (Rupees Five Hundred only) for each occasion.

UNAUTHORIZED DRIVING

- (84) Contractor should ensure that the RMTs are driven only by valid license holders. Failing which a penalty of Rs.5000/- will be levied by the Union for the first occasion and the contract for the RMT will be terminated on the subsequent occasion.

REFUSAL TO PLY THE RMT IN THE ROUTE ALLOTTED BY THE DUTY OFFICERS:

- (85) The RMT should ply normally in the route allotted to it. Due to administrative reasons the RMT intended for one route may be allotted to ply in any other route by the duty officer concerned and it is the responsibility of the contractor to ply the RMT in the allotted route. Any refusal on the part of the contractor will attract a penalty of Rs.500/- (Rupees Five hundred only) for each occasion.

Noted and agreed to the above

SIGNATURE OF THE BIDDER

SUBSTITUTE RMT:

(86) In the event of the contractor not being able to provide the required number of RMTs, the Union reserves the right to engage RMTs from other sources or ply Union's own RMTs and the additional expenditure incurred thereof would be recovered from the contractor.

SECURITY DEPOSIT

(87) The security Deposit is liable to be forfeited in case of termination of the contract.

(88) No interest will be paid on the Security Deposit.

(89) In the event of extension of contract, the Security Deposit shall be retained for the extended period of contract or the contractor shall extend the Bank Guarantee period to the extent of extension of contract period.

(90) The Security Deposit shall be refunded after six months of the successful completion of the contract or audit / reconciliation whichever is earlier and subject to the production of original receipt.

LEGAL ENTITLEMENT

(91) Union shall be entitled to file criminal case against the contractor, if the contractor commits any offence as defined under various laws in-force.

UNIFORM TO VEHICLE CREW:

(92) The contractor shall provide Khaki uniform to the vehicle driver and it is the duty of the contractor to ensure vehicle drivers wear uniform while they are on duty.

RIGHT TO ADVERTISE:

(93) The Union shall have the right to have advertisement on the RMTs. The contractor cannot make any objection or claim any charges on this from the Union.

PAYMENT OF STATUTORY DUES:

(94) The contractor should ensure that all statutory dues / remittances such as road tax, insurance etc. are paid up to date and the Union will not be held responsible for any lapses or default in this account.

Noted and agreed to the above

DEDUCTION OF STATUTORY TAXES

(95) Income tax at the prevailing rates shall be deducted from each running bill of the contractor, in accordance with the income tax act in force. The necessary certification for tax deduction will be issued once in a quarter.

INSURANCE

(96) The contractor shall arrange for insuring the cost of milk transported in his RMT (Cargo Insurance).

GENERAL

(97) The General Manager of the Union reserves the right to add, subtract or modify any of the terms and conditions and clauses of the agreement with the consent of the contractor during the contract period.

(98) The General Manager of the Union reserves the right to impose penalty at his discretion for any misdeed or violations not mentioned in the agreement.

(99) For all disputes arising out of the terms and other matters the decision of the General Manager of the Union will be final and binding.

(100) The relationship between the Union and the bidder is one of principal to principal and not one of principal to agent.

(101) The tender conditions also will form part and parcel of this agreement.

TERMINATION OF CONTRACT

(102) The contract can be terminated by the Union, if any default is noticed as per tender terms and conditions by giving 30 days notice to the contractor.

ARBITRATION

(103) The parties hereby agree to resolve any disputes arising out of this agreement through arbitration by the sole arbitrator appointed by the General Manager of the Union and agree that the Arbitration and conciliation Act 1996 will apply.

TERRITORIAL JURISDICTION

(104) The parties hereby agree to take recourse to their legal remedies within the territorial jurisdiction of the Deputy Register (Dairying) Court at
