1. Preamble

The Tamil Nadu Cooperative Milk Producers Federation known by the brand name "aavin" is producing varieties of ice-creams at Chennai, Madurai and Salem with a total installed capacity of about 45,000litre per day and has got an additional capacity of 10,000litre per day to produce Kulfi at Villupuram, Salem, Vellore, Krishnagiri and Tirunelveli. Further the Federation and its affiliated coop district unions are in the process of expanding the installed capacity for producing ice creams. Having adequate capacity to cater the market, TCMPF Ltd., wishes to award contract for sale of Ice-Creams through appointment of Stockist at various locations in Chennai Metro and other Districts of Tamil Nadu. The trade margin for sale of Ice cream is 30% on the MRP.

In this regard, TCMPF Ltd., invites interested dealers with adequate eligibility to send their Expression of Interest in the prescribed format for getting appointed as stockist for a period of 1 year for sale of ice creams at different areas mentioned in **Annexure -1**. The list of ice-Creams varieties produced by TCMPF Ltd., and its affiliated Unions along with MRP is mentioned in **Annexure -2**.

The interested Tenderers have to participate in the eTender and submit their Expression of Interest only through online (www.tntenders.gov.in) along with the necessary supportive documents.

2. Scope of Work

- 1. The stockist shall be awarded contract for sale of Ice creams in the area/areas assigned to them for a period of 1 year.
- 2. The stockist shall give indent for ice creams well in advance through mobile application or in the prescribed format, preferably before 2 working days from the date of supply.
- 3. The stockist shall make payment towards the value of the invoice through RTGS and the payment details shall be shared with products accounts section.
- 4. Upon confirmation, the stockist shall deploy reefer vehicle to receive the stocks from the dairies/storage locations.
- 5. The Stockist shall abide the modalities followed during the supply of stocks at dairies/storage locations without any deviation.
- 6. The stocks once delivered to the stockist will not be taken back by the Federation for any reason.
- 7. The stockist should ensure that the ice cream stocks are maintained under the cold chain preferably at -24°Celsius throughout the entire supply chain from the point of receipt of the stocks.
- 8. Any damages observed to ice creams which includes formation of frost or if the ice cream is found to be stored above -18° Celsius or any reasons not mentioned herewith which affects the quality of ice creams during any inspections/Audit then recovery of same will be charged from the stockist.

- 9. The stockist is expected to maintain the stocks in the cold room and reefer vehicles as per the FSSAI prescribed guidelines
- 10. The stockist shall make arrangements for dispatch of ice creams on FIFO basis and in batch wise and code wise manner.
- 11. The stockist should deploy adequate manpower for increasing the sale of ice creams and TCMPF Ltd will not provide any payments for the same.
- 12. The stockist shall sell ice creams to retail outlets only in the areas allocated to them as per the guidelines set by TCMPF Ltd., from time to time and they should not sell in other areas.
- 13. The stockist shall share the details of sales made to retail outlets on a daily basis and take necessary actions to improve the sales at these outlets. TCMPFL Ltd., shall consider to provide cold storage facilities such as bottle coolers, deep freezers and visi-coolers to retail outlets based on the availability and expected sales outcome.
- 14. The stockist shall maintain adequate stocks of ice cream in their cold rooms at all time and ensure that the market is catered without any shortages or complaints.
- 15. The cold room and the reefer vehicle are to be maintained in proper condition by the stockist and this will be audited by TCMPF Ltd., through regular/surprise inspections.
- 16. The stockist shall arrange to deploy the point of purchase merchandise at all retail outlets based on the campaign run by TCMPF Ltd., from time to time.

- 17. The stockist are expected to lift a minimum quantity of ice cream and their performance will be reviewed from time to time.
- 18. If the performance of the stockist is not as per the commitments mentioned in the commercial bid or if the market is not realized to its full potential, TCMPF Ltd., shall appoint additional stockist for the same area as a whole or partially at its discretion.
- 19. Incentives may be offered based on performance of the stockist at the discretion of the Federation from time to time

3. Qualification Criteria

- Cold Storage: The Tenderer should possess cold storage capacity for storing a minimum of 5000litre of ice cream. The cold storage may be in the form of chest freezers or cold room. The cold room may be owned / leased by the applicant. The applicable supportive documents should be furnished along with the tender.
- 2. Reefer Vehicle: The Tenderer should possess reefer vehicle with a minimum carrying capacity of 500litre of ice cream. The reefer vehicle may be owned / leased by the applicant. The applicable supportive documents should be furnished along with the tender.
- 3. If the tenderer has applied for sale of ice creams at more than one area, they should possess additional infrastructure of Reefer vehicle (minimum 500litre capacity) and cold storage (5000 litre capacity) for each and every area.

- 4. The Tenderer must have successfully executed one similar contract involving sale of ice creams or other FMCG products in last 3 years of time and PO copy of the concern organization is required for reference purpose. Data will not be used or disclosed anywhere and it will be just for verification purpose.
- 5. The bidder shall have an average annual sales turnover of at least 1 crores during the last 3 financial years duly certified by a practicing chartered accountant.
- 6. The following documents shall be valid during the course of tender process and further during the contract period.
 - 1. Company Incorporation Certificate / Memorandum of Association / Partnership deed.
 - 2. PAN No.
 - 3. GST No.
 - 4. FSSAI Certificate (for both vehicle and storage facility)
 - 5. Registration certificate, Fitness, Insurance and permit suitable for ice cream transportation of the reefer vehicle.
 - 6. Road Tax.
 - 7. Lease documents if applicable

4. EOI - Tender Process

- 1. The tender documents can be downloaded online from www.tntenders.gov.in / www.aavin.tn.gov.in at free of cost.
- 2. The tender fee of Rs.1000 inclusive of GST and EMD of Rs.1 Lakh shall be paid through e-portal and the details of the same shall be furnished in the prescribed format in the tender document.

- 3. A pre-bid meeting will be conducted as scheduled in the tender detail which the tenderers shall interact with the concerned officials of TCMPF Ltd., and clarify their doubts pertaining to the terms and conditions of the tender.
- 4. The Tender should be submitted only through online at www.tntenders.gov.in along with the necessary supportive documents on or before as schedules in the tender detail.
- 5. The tenderer shall sign in every page of the tender document and shall ensure that the document is complete in all respects.
- 6. The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document. In the latter case, authorization letter should be attached.
- 7. The tenderer should read each and every page of the tender document and understand the implications fully and offer the tender only if he could discharge the obligations set out in the tender documents.
- 8. The offer of the tender in the commercial bid should be valid for a minimum period of 180 days from the date of opening of the Technical Bid.
- 9. The tenderer who are downloading the document from the website are instructed to look for any corrigendum after the date of pre bid meeting, for any amendments if any issued. They are advised to download the above amendment and enclose it without fail along with the technical bid document, duly authenticating.
- 10. If the tenderer has already been blacklisted by any Government/
 Government Undertakings / companies / Other Cooperative
 Federations or Unions, the tender will be rejected. In case
 information about such black- listing comes to the knowledge of the

Federation after awarding of the tender, the contract will be terminated, liquidated damages will be levied apart from taking penal action including blacklisting. The Security Deposit will be forfeited.

5. GENERAL TERMS AND CONDITIONS

- 1. The Tamilnadu Cooperative Milk Producers' Federation Ltd. will not accept any variations in conditions stipulated in the tender.
- 2. Any suggestion in the tender, for any modification of the tender conditions will not be entertained and the conditional offer will render the tender invalid.
- 3. The tenderer can attend the pre-bid meeting where the clarifications sought for by the tenderer will be given and the minutes of the pre-bid meeting will be uploaded in the aavin website.
- 4. Any failure on the part of the tenderer in performing the contract for the full contract period will render the tenderer liable for penal consequences and liquidated damages as specified in the tender agreement which also forms part of tender document.
- 5. The tenderers should submit their bids only through eProcurement Portal (https://tntenders.gov.in). All other details can be seen in the tender documents, the tender documents can be downloaded from www.aavin.tn.gov.in and https://tntenders.gov.in. Corrigendum / Addendum to this publication, if any would appear only on the above said websites. The Technical Bids shall be opened through online eProcurement Portal (https://tntenders.gov.in) on aforesaid date at above mentioned address.

6. Period of Contract

1. This tender is for the sale of aavin varieties of ice creams through appointment of stockist for a period of 1 year from the date of awarding the contract.

7. Tender Fees & EMD

- 1. A Tender fees of Rs.1,000/- inclusive of GST (Non-refundable) and EMD of Rs. 1,00,000/- (Refundable) shall be paid through ePortal. Any tender submitted without the Earnest Money Deposit will be summarily rejected
- 2. Tender Fee and EMD will not be accepted in any other mode like cash or cheque. The quotation received without Tender Fees and EMD shall not be considered. EMD will carry no interest.
- 3. In case if the bid has not been accepted, the EMD will be refunded and will not carry any interest. In case, during the physical evaluations, the infrastructure facilities as mentioned in the tender is not available with the bidder, the tender bid will stand rejected and in such cases a token penalty of Rs.5000/- will be deducted from the EMD.

8. Evaluation of Tender

1. Evaluation of Technical Bid

1.1 The documents such as PAN, GST registration, FSSAI Certificate and payment of EMD will be verified and the tederers with valid certificates will be evaluated further. The bids of tenderers who have not submitted valid PAN/GST/FSSAI Certificates/non-remittance of EMD will be rejected.

1.2 The 2nd step of Technical bid consists of evaluating the infrastructure facilities such as reefer vehicles, cold storge facility, past experience, past sales turnover of the tenderer. The supportive documents pertaining to the above aspects will be evaluated and weightage will be offered as detailed below:

The tenderers will be ranked based on the points gained as above.

- 1.3 The infrastructure facilities that are mentioned by the tenderer in the technical bid will be physically verified by a competent team nominated by the tender inviting authority.
- 1.4 Any descripancies found between the datas provided in the technical bid and the outcome of the physical evaluation, the penality of Rs.5000/- shall be levied upon the tenderer and the same will be deducted from the EMD.
- 1.5 The tender will be pronounced as qualified for opening of commercial bid only if they meet the minimum qualifying requirement as mentioned in the clause 3 of this tender document.

2.0 Evaluation of commercial Bid

1. The sum total of business volume as quoted by the tenderer for one contract period will be considered during the commercial bid evaluation. Weightage points will be assigned to the tenderers as detailed below:

2. The sum total of all points in the technical bid and commercial bid will be calculated and ranking of the tenderer ie., H1, H2, H3 etc will be decided on the basis of descending order of points secure for the contract period of 1 year.

9. Empanelment of Stockist

1. The tenderers who qualify through the technical and physical evaluation will be empaneled for allocation of areas for sale of ice creams. The tenderers shall be ranked based on the total points secured in the technical and commercial bid and area of operation will be allocated based on the preference cited by the tenderer and the designated ranking awarded in the tender.

10. Award of contract

- 1. The contract shall be awarded based on the rankings obtained by the tenderers during the evaluation process. The tenderers with the highest rank shall be given preference for allocation of areas.
- 2. If two or more tenderers secure equal points for the same location or area the absolute value of the business volume quoted by the tenderer will be consider for awarding of contract.

11. Execution of Agreement

1. The successful bidder has to execute an agreement on Rs.100/- non-judicial stamp paper incorporating the terms and conditions of this EOI - tender for sale of ice cream through appointment of stockist within 15 days from the date of award of contract.

12. Satisfactory Execution of Contract

- 1. The tenderer is expected to adhere to the ice cream offtake value as mentioned in the commercial bid without any deviation. If the tenderer fails to lift the ice creams as per the value specified in the commercial bid / final negotiation, TCMPF Ltd., may issue a show cause notice to the tenderer.
- 2. If the tenderer continues to lift less ice creams for Second consecutive month, the Federation at its discretion shall either terminate the agreement with the stockist or provide reallocation of areas.
- 3. Further during the course of the contract, if the Federation deems fit, may at its discretion appoint additional stockist for the areas through partial/complete reallocations so as to improve the sale of ice creams.

13. Specification of Reefer Vehicles, Cold Storage

- 1. The reefer vehicles should have a minimum carrying capacity of 500litre of ice cream carrying capacity and cold storage shall be 5000litres ice cream storage capacity.
- 2. The quality standards shall adhere to FSSAI norms.

14. Security Deposit

Post issuance of work order the EMD remitted will be converted into Security Deposit. Further for every additional area which has been allocated Rs.1 lakh Security Deposit will be collected additionally. In case of any quality complaints or non-satisfactory performance (not adhering the minimum quantity to be lifted per month) TCMPF Ltd., may recover losses, penalties, applicable GST from the Security Deposit and amount payable to the bidder. After deduction of the same, the balance amount will be released to the bidder. Further, if the losses incurred exceed the value of Security Deposit, the same amount will be claimed from the stockist.

1. The security Deposit shall be returned to stockist after 6 months from the date of completion of the contract with satisfactory performance.

15. Associate Membership:

1. The Tenderer shall become an Associate member by paying the required fees prior to lifting of the stocks.

16. Arbitration:

1. Any claim upto Rs.10 Lakh arising out of any dispute under this contract shall be referred to arbitration before Deputy Registrar (Dairying) Court, Thiruvallur. The decision of the arbitration shall be binding on the tenderer. The language of the arbitration shall be English. All other disputes under this contract shall be referred to the court within the jurisdiction of Chennai.

17. Jurisdictional Limit:

1. In the event of any litigation arising out of this contract, the jurisdictional limit shall be Chennai only.

18. Force Majeure:

- 1. Should any of the Force Majeure circumstances, namely act of God, natural calamity, fire, Government of India Policy, restrictions (excluding any stock limits), strikes or lock-outs by workmen, war, military operations of nay nature and blockades preventing the Tenderer from wholly or partially carrying out their tender obligations, the period stipulated for the performance of the Tender shall be extended for as long as these circumstances prevail, provided that, in the event of these circumstances continuing for more than three months, either party shall have the right to refuse to fulfill its contractual obligations without title to indemnification of any losses it may there by sustain.
- 2. The tenderer or supplier whoever is unable to carry out its Tender obligation shall immediately advice the other party of the commencement and termination of the circumstances preventing the performances of the tender. A certificate issued bythe respective Chamber of Commerce shall be sufficient proof of the existence and duration of such circumstances.
- 3. I / We hereby declare that I/We read all the tender conditions and the details of annexures enclosed thereof, have fully understood the implications thereof/We also declare that we shall adhere by the rules and regulations of the TCMPFLtd stipulated in the tender document. I / We shall maintain the official decorum and discipline at the time of tender.
